## Referring Physicians Portal

Give referring physicians secure, remote Web access that they will actually use!

- With the Zero Footprint viewer, providers can log into the portal and view both images and reports from any device without download or configuration
- No VPN required to launch images when accessing outside their network
- Can access patients, reports and images within their physician group
- Permission based, physicians can CD Burn/export their patient studies
- Electronically create, send, and sign off on exam orders

- Their images and reports. Reports can be downloaded, saved and/or printed


